#### **Welcome**

The Provost welcomed everyone to the meeting.

#### **Police Matters**

PC Paul Owenson (Police Scotland) was currently on annual leave and had submitted his apologies. The March MMWR had not been received. PC Owenson had advised the Provost 80 letters had been issued to residents and businesses within the Town Centre regarding parking and he was pleased to report that the issue of staying more than the allotted 2 hours had vastly improved. SBC Councillor Tom Weatherston advised the meeting that there was no longer a CAT (Community Action Team) but the number of Police Officers remained the same. SBC Councillor Euan Robson advised the meeting that a Working Group had been set up to look at the issue of parking throughout the Borders.

SBC Councillor Weatherston reported that there had recently been a group of travelling people on the Industrial Estate. Whilst they had now moved on, they had left behind a great deal of rubbish. SBC are looking at who is responsible for the land, as the rubbish is not on SBC land. He said it was imperative that Scottish Borders Council found a permanent site for travelling people.

The Provost reported that there had been incidences of people emptying rubbish at the vennel near the Co-op that leads down to the Cobby in Roxburgh Street.

#### Visit Kelso

The Provost reported, on behalf of Visit Kelso, that their new leaflet was almost ready and would be distributed shortly. Applications had gone out for this year's hanging baskets. Visit Kelso was intending to hold a 'Meet and Greet' for all members as the group is 10 years old this year.

# **Questions From The Public**

# (i) Berrymoss Court – Trees between Sydenham Court/Berrymoss Court (SBHA)

Councillor Gail Watson asked if there was any update with this issue? SBC Councillor Euan Robson advised that he was having a meeting with representatives from SBHA and this was top of the list.

It was also reported that there had been an old sofa lying at the bottom of Kelso Ice Rink car park for some considerable time – SBC Councillor Robson advised that, although this was not a Scottish Borders Council issue, they did try to flag these things up to SBHA.

#### Kelso In Bloom

The Provost advised that the next litter-pick would take place on Thursday 17 April 2025 at 7pm to which all were welcome to take part. He had hoped for Kelso in Bloom to fill the edges of Bridge End Island with topsoil and sew grass seed to bring the edges back out to the kerb edge. Repairs to the kerbs have now been completed by SBC Roads Department, with the Provost's thanks.

# **Provost Report**

# (i) VE Day Commemorations

The Provost advised that plans for the VE Day Commemorations were coming along nicely. He and Councillor McCombie had met with Jenny Wilkinson from SBC and advised that an area in front of the Cross Keys, Kelso would be cordoned off on the day for various displays and activities, etc. The Parade would start from the Tait Hall, moving along to The Square, then back to the Tait Hall. There would be 3 Pipe Bands; the Lord Lieutenant (or his Depute) and the Minister of State for the Army would both be giving a speech. The activities in The Square would be finished by 4pm with the Beating of the Retreat being held at Floors Castle. As the Provost will be on holiday during this time, Vice-Chairman Councillor James Boulton will deputise.

# (ii) Time Capsule (Wednesday 9 April 2025)

Members were advised that the bullring had been opened up in readiness for the re-burying of the Time Capsule the next day (10 April). He had received various items to bury together with those items recovered when the bullring was opened up, following King Charles' coronation in April 2023.

## (iii) Kelso Community Council Elections Advice

The Provost had spoken to Fiona Henderson, Scottish Borders Council, who confirmed that the Community Council elections will be held in September/October 2025 with the present Kelso Community Council's final meeting being held on Tuesday 9 September. The Provost proposed that SBC Councillor Tom Weatherston act as Returning Officer for the elections and this was seconded by Councillor James Boulton. SBC Councillor Weatherston agreed to undertake this duty.

# **Scottish Borders Council Report**

#### (i) Roxburgh Street Pavements

Councillor Toni Oliver commented that the state of the pavement in Roxburgh Street from Lindsay's, Opticians to the Co-op was dreadful and she knew of at least 2 people who had tripped and fallen on the uneven surface. SBC Councillor Tom Weatherston stated that this had been reported and will be down to the specific utility companies to repair.

## (ii) Union Street

SBC Councillor T Weatherston advised members that he had been told the skip must be removed by the end of the month (April) and the road re-opened.

#### (iii) Trinity Church

The Provost advised that the owners of Trinity Church were now back living in the caravan, and he had written to them for an update on the refurbishment of the church.

# (iv) Baptist Church

SBC Councillor Robson advised that there had been 2-3 people looking at the Baptist Church and he had asked the Estates Department of SBC to investigate.

# (v) Rosebank Cemetery

SBC Councillor Robson informed members that the paths at Rosebank Cemetery had been inspected and work will be done to upgrade them (hopefully during this new financial year).

# (vi) Lighting at various locations in Kelso

SBC Councillor Robson advised that some of the low lights in Shedden Park had been vandalised again. As these lights cost £1,000 each, he said that, should they be vandalised a further time (after repair), he feared they would not be replaced again.
